Ideas to Grow our IRTA Membership

The IRTA is always looking for ways to maintain current members as well as recruiting new members. The state membership committee met recently, and we developed a list of some viable approaches that a local might use in order to recruit new local (and state) members. Keep in mind that this list is only a starting point – we hope these ideas prove to be beneficial!

- Make prospective members feel important --- include all school personnel (nurses, cooks, paraprofessionals)
- Don't take age into consideration remember that associate members can be any age!
- Build a club web site
- Use group email / text to promote your club
- Make it FUN
- Interview a current teacher, then publish the interview
- Repeatedly invite prospective members --- remember, "just keep after them" -- Bud King
- Have members of your local RTA do a local "work day" with current staff build goodwill!
- Prepare and present gifts for 1st time attendees at a local meeting
- Make personal contact with prospective members. Call them, or visit them in person! "Just keep after them" Bud King
- Prepare treat bags for all staff at one building (or corporation) as your group service project. Include some membership forms!
- Mentor with active teachers to explain how IRTA works (and doing things to help them in the classroom)
- When possible, visit the schools. Ask to speak briefly at faculty / staff meeting (contact district HR or Supt.)
- Mail letters with membership form included to current retirees that are not members of IRTA. Follow up with a phone call. Remember "just keep after them". Bud King
- Hold a "Not Back to School" lunch to celebrate the retired life!
- Host a Retirement Workshop in your county


