The Times They Are A-Changin'

The title of this article was borrowed from a Bob Dylan song he sang in 1964. Change is still occurring today, 60 years later. And while change is occurring in nearly every facet of society, I am going to focus on the change in pension enhancement philosophy that has occurred at the Indiana General Assembly and particularly the Indiana Senate, in the last eleven years.

I was hired as the lobbyist for the Indiana Retired Teachers Association in 2013 – thank you Nancy Tolson! During the first four years of my tenure, IRTA focused our lobbying efforts exclusively on obtaining a COLA. I distinctly remember one legislative luncheon at the Statehouse where we placed cans of Coke on the high-top tables spread around the north atrium. But our efforts fell on deaf ears in the Republican controlled Indiana Senate. Senate fiscal leaders were concerned about the long-term cost of the COLA as it accrues year after year and the cost is more than three times greater than a 13th check. A COLA was off the table as far as the Senate was concerned. And it's not like they were eager to provide a 13th check. We had to lobby very hard to get a 13th check every year, but to their credit, the Senate came through every year until 2021 when we were surprised by a change in their pension enhancement philosophy.

On the last day of the 2021 legislative session, we learned that retired teachers would receive a 1% COLA. Word from the Senate was that "we are out of the 13th check business." We were shocked and not particularly happy as some of our older retirees would receive a pittance compared to a \$450 13th check. I truly believe that the Senate leadership thought that they were doing a great thing for retirees and were hurt by our reaction to the COLA, which probably could have been avoided had they communicated with us during the legislative session.

Retired teachers did not receive another COLA in 2022 and nothing again in 2023.

Fortunately, after much hard work from all IRTA members, retirees will receive a 13th check in 2024 and legislation also passed establishing the framework for an automatic COLA or 13th check in the future.

The legislation establishing the framework for a future automatic COLA or 13th check (HB1004) is a very positive step in the right direction but represents another change in the Senate pension enhancement philosophy. While IRTA has advocated for automatic pension enhancements like those received by police, firefighters and judges for several years, the Senate has opposed

When navigating the legislative session, from start to finish, there are twelve steps to passing a bill (which follow the article). Deadlines are set, and if a bill fails to advance, it becomes a "DEAD BILL." This is the simplified version of the process. During the 2024 session, the language of HB1004 (13th Check) and SB275 (Pension Matters) was eventually combined. Despite the obstacles in the Senate, HB1004 (13th Check and Pension Matters for the future) passed out of both the House and the Senate on March 8th. 2024. The feeling of success that comes when so many people are working together for the common good of retired educators was overwhelming! I would be remiss if I did not personally thank all of the House of Representatives, especially Representatives Cherry, Thompson, Porter, Moseley, Snow, Smaltz, Bartlett, and Speaker of the House Huston. I also wish to thank Senators Niezgodski, Qaddoura, J.D. Ford, Hunley, Pol, Randolph, Taylor, Vinzant, Yoder, Alting, Becker, Bohacek, Deery, Dernulc, Goode, Leising, Tomes, K. Walker, and Buchanan. If you did NOT receive the IRTA Email Blast announcing the passing of a 13th Check, and you are a MEMBER, please let our office know!

Communication continues to be the challenge and the key to moving forward. Under the Advocacy Tab on our website, is a short tutorial explaining how to navigate the Indiana General Assembly website. It

is important that you stay informed as we plan for January 2025. As IRTA President, David Lennen mentioned, we are running a marathon, not a sprint. Life thrives on small moments, and it takes consistent, thoughtful decision-making to do it well. I'm excited to share that our Fall Workshops will have an Advocacy Focus! Stay tuned for more information about the long-term pension enhancement plan in HB1004!

The Twelve Steps of Legislative Process

Introduction: A legislator introduces a bill in either the Indiana House of Representatives or the Indiana Senate.

Committee Assignment: The bill is assigned to a relevant committee in the chamber where it was introduced.

Committee Consideration: The committee holds hearings, debates, and may amend the bill before voting on whether to advance it.

Committee Report: If the committee votes to advance the bill, it is reported back to the full chamber with any recommended amendments.

Second Reading: The bill is read for the second time in the chamber and placed on the calendar for further consideration. **Floor Debate:** The bill is debated on the floor of the chamber, where further amendments may be proposed and discussed.

Third Reading: The bill is read for the third time, during which final debate occurs, and a vote is taken on whether to pass the bill.

Engrossment: If the bill passes its chamber of origin, it is engrossed, meaning it is prepared in its final form for consideration by the other chamber.

Second Chamber: The bill is transmitted to the other chamber (House or Senate),

where it undergoes a similar process of committee review, floor debate, and voting.

Conference Committee: If the two chambers pass different versions of the bill, a conference committee may be appointed to reconcile the differences between the versions.

Final Passage: Once both chambers agree on the bill's language, it is voted on for final passage in each chamber.

Governor's Action: After passing both chambers, the bill is sent to the Governor for approval. The Governor may sign the bill into law, veto it, or allow it to become law without signature. If vetoed, the General Assembly may override the veto with a two-thirds majority vote in each chamber. If the Governor signs or the veto is overridden, the bill becomes law and is assigned an effective date.

There was a good turnout, and the current educators appreciated the opportunity to learn about their retirement options.

I hope you are staying informed about the activity in the state legislature. Staying in touch with legislators is a year-round activity! We must maintain our momentum at the statehouse and support the efforts of our state lobbyist and our Executive Director. Think of the legislative process as a marathon, not a sprint. Even though there may be a few setbacks along the way, we continue to work toward the goal of an annual pension enhancement for all retired educators in the state.

Finally, I encourage you to attend two events later this year. The annual Representative Assembly will take place on Wednesday, June 12 in Indianapolis. Every local RTA has the opportunity to send delegates to this meeting. The morning session is the annual business meeting of the association, and the afternoon session is our celebration for individuals and local RTAs that have gone above and beyond the call of duty within the IRTA. Then, in September, make plans to attend one of the fall workshops that will be held around the state. Although firm dates have not been established, the window for these workshops is between September 18 - 26. Watch for specific dates and locations. Fall workshops are open to all that are interested in the IRTA.

automatic enhancements because they have greater fiscal control when they have to approve any enhancement.

HB1004 directs INPRS to develop the administrative capability to automatically pay a 1% COLA or 13th check every year and allows them to raise the cap on the local contribution to fund long term pension enhancements. Retired teachers and public employees who retired before July 1, 2025 "date certain" will receive a 13th check every year. Those retiring after that date will receive a COLA. But HB1004 has one glaring omission: there is no implementation date. INPRS has suggested that the plan will not be fiscally viable until 2029, which could be the implementation date, but there is no guarantee. And the July 1, 2025 "date certain" is troublesome. IRTA suggests basing the date certain on the analysis of INPRS retiree data and not the arbitrary date that was chosen. IRTA prefers a date certain that is the most beneficial to all of our members - some benefit more from a 13th check while others will benefit more from a COLA. IRTA will work with the Pension Management Oversight Committee beginning this summer to consider funding options, a different date certain and an implementation date.

There have been many frustrating moments working on pension enhancements. But it is important to give the legislature credit where it is due – the General Assembly has been and remains 100% committed to protecting current pensions. Significant investment (approximately \$1B per year) has occurred every year since the late 1970s to pay down the unfunded liability of the Pre-'96 Teachers Retirement Fund which is on schedule to occur in 2029. Retirees in Indiana can sleep well at night knowing that their pension is safe.

Area I Director Completes Collette Tour COSTA RICA: A WORLD OF ADVENTURE

In February 2024, with 22 participants from throughout the US I completed the 12-day Collette Travel Tour of Costa Rica. The tour was an adventure with even more activities than advertised, thanks to our native guide, Rebecca Gomez. Rebecca was so proud of "her" country as she guided us through Tortuguero National Park and turtle sanctuary,



Tirimbina Rain Forest Center, cacao bean chocolate making demonstration and tasting, cooking demonstrations, river safaris, forest reserve walks, hanging bridges hikes, jungle crocodile river exploration, bird watching, monkey sightings, coffee plantation and processing demonstration, and swimming at Manuel Antonio National Park beach with monitors watching our bags so they were not stolen by the MONKEYS! Volcano walk was cancelled because of rain, despite this being the "dry" season. Zip lining was included was we individually zipped up to 40 mph on cables to 5 different platforms high above the rain forest [my legs are still shaking!] and optional white water rafting was a choice.

The daily temperature was in the mid-80's as I saw sloths, alligators, "jesus christ" lizards, crocodiles, monkeys, toucans, sloths, tiny poisonous frogs, a snake, iguanas and many species of birds. [Unfortunately, there was no jaguar which the prior week was seen swimming across the river.]

The 12-day trip with 5 different hotels provided 23 meals--11 buffet breakfasts,

4 lunches and 8 dinners. Flights for the 4 Indiana participants were routed from Indianapolis to Houston by United Airline, then the $3\frac{1}{2}$ hour flight to San Jose, Costa Rica.
