
# BULLETIN BELLARD WINTER 2023



Next, the bill goes to the Senate and the whole process begins again. At any time during the process, there may be amendments, changes, or the bill may be dropped by a committee chair and not even heard. Since the committees are doing most of the work on Tuesday, Wednesday, and Thursday, the whole process takes weeks. If it finally has been through Senate committees and the floor of the Senate, but the bill is different in the House and Senate versions, there has to be a final decision between them in a Concurrence Committee.

Through all this, legislators are hearing from many groups who want to be included in the budget. They hear from the LSA (Legislative Services Agency) about the money available for the next two years. Legislators also get information about what other states are doing, what the federal government is doing, and finally, they may hear from you.

SO—if an addition to your pension is important to you, we, your IRTA Legislative Committee, strongly urge you to be in touch with your Senator and Representative.

# From the Desk of the Executive Director

Sometimes you will never know the value of a moment, until it becomes a memory.

- Dr. Seuss

In May of 2012, as the Principal of Central Elementary in Plainfield, I stood in front of students, staff, parents, and community members to dedicate our newly constructed brick sign. Enclosed within one side of the structure was a time capsule. The staff had spent months planning the ceremony and teaching their students the history and significance of time capsules before the carefully chosen items were encapsulated for the next twenty-five years. It was a day of making memories!

As I think back to that day, I wonder how many of us consider what we will leave behind, and what we will be remembered for? What will be our legacy?

One educator that left behind a legacy - hoping to make a difference in the lives of retired educators - was Dr. Ethel Percy Andrus. When Dr. Andrus, a California high school principal, retired in 1944, several local and state groups had already formed to support retired educators.

After retirement, Dr. Andrus started witnessing, first hand, teachers whose pensions had been eroded by inflation and rising health care costs. One day, Dr. Andrus was asked to pay a call on a retired Spanish teacher living in Southern California. When Dr Andrus arrived at her destination, she

found this former well-respected teacher living in a chicken coop on a \$40 monthly pension. The Depression and flooding had taken the property she had planned to build on years earlier. The chicken coop was the only home the retired teacher could afford. It is hard to believe that a dedicated teacher could ever fall on such hard times!

In 1947, Dr. Andrus founded the National Retired Teachers Association (NRTA) to address the economic needs and health insurance challenges of educators in retirement. Soon, the advocacy and benefits that NRTA and individual state RTAs provided to retired educators became so popular and important that non-educators were looking for guidance and assistance. In 1958, Dr. Andrus continued with her legacy and founded AARP (then known as the American Association of Retired Persons).

The Indiana Retired Teachers Association (IRTA) was established in 1950 as the only organization that concentrates exclusively on the welfare of retired educators of Indiana. To think that NRTA and IRTA are 76 and 73-years-old respectively is a history to be proud of! I am thankful that so many retired educators that came before me worked so hard to make sure that I had a better future when I retired!

IRTA has come a long way since 1950. Sharing what we do and who we are at our Representative Assembly, regional workshops, and local meetings is important, but we would like to reach beyond retirees in Indiana. In a few short weeks. IRTA will be hosting our 2nd Virtual "Connecting" Workshop from 10 a.m. to 3 p.m. on January 25th, 2023. It is our vision to reach all IRTA "Members Across the Map." We have Indiana retirees living throughout the United States from California (491) to Texas (713) to Florida (2,770), and even Maine (38). Our database shows over 5,500 Indiana retirees living in Michigan, Ohio, Kentucky, and Illinois!



#### AMBA Round-Up, Time in Austin, Tx

I had the honor to represent IRTA at the AMBA Roundup in early November. Laura Penman, IRTA Executive Director was also planning to attend, but canceled due to illness. Although we missed her, my husband Steve and I enjoyed ourselves. The trip was filled with fun, food and making new friends. The staff of AMBA and the resort rolled out the Texas hospitality. YeeHaw!

There were two days of meetings focused on information and ideas of how to recruit and retain members. Growing membership is a common concern of all the groups in attendance. One of the discoveries I made was AMBA provides benefits for over 80 organizations across the United States. These organizations represent not only retired educators, but also active educators and public employees, both active and retired. In talking with representatives from other states, I found groups that combined different types of groups (active and retired, educators and public employees). I thought these combinations would make membership campaigns more challenging.

The presentations on membership included discussion on Baby Boomers (born 1945 – 1964), Gen Xers (born 1965 – 1979) and Millennials (born 1980 – 2000): their needs/personality traits, how to recruit them, what they want from organizations and how to retain their memberships. IRTA needs to focus on Baby Boomers and Gen Xers. The IRTA Board and Membership committee will be discussing this information, and how we can benefit from the information I heard.

AMBA did provide an overview of their products and services. They promote some of their products through Lunch and Learn seminars. At these events, AMBA makes the contacts, pays for the meals and makes the presentations. AMBA does contact the local RTA groups, so this would be an opportunity for members from your group to attend and connect with those in attendance. Invite them to a meeting or to give information about your local group.

During the conference there were two featured speakers. The first day it was Tom Morris, a modern day philosopher. He was entertaining, as he gave an overview of his book, Plato's Lemonade Stand. He noted we have all heard the phrase, "When life hands you lemons, make lemonade." He noted, however, that no one told you how to do that. He uses Plato and other philosophers to give a recipe:

The Art of Self-Control, The Art of Positive Action and The Art of Achievement. By using the steps within each part of the recipe, it is possible to reshape your thinking to help to deal with the uncertain and changing times.

The guest speaker for the second day was Mike Carr. He was the 2020 Toastmasters International World Champion. His time sped by as he presented information that was interwoven with stories about his childhood and life. The point he made was, people are 22% more likely to remember a fact when wrapped in a story. My take away is to use this when I am speaking to a group. Also, I think we all need to remember this when we write or email our legislators. Include your personal stories on how the stipend or 13th check, or the lack thereof, affects you. This is what will catch their attention and evoke a response.
